Required Documentation

- This application should be accompanied by original invoices and/or receipts with
 - (i) The name of the farmer/organization on the receipt, Supplier's name and
 - (ii) signature, telephone number.
 - (iii) Type of service or product supplied.
 - (iv) A 10 cent Barbados stamp for receipts and rubber paid stamp for invoices.
- A design of the Irrigation System.
- A letter of authorization from the Barbados Water Authority (BWA) is necessary for sinking a well.

NB: All invoices and receipts must be submitted within THREE (3) MONTHS of services rendered.

A rebate of 50% up to a maximum of \$60,000 for an individual holding or 60% to a maximum of \$72,000 where the irrigation is shared or for co-operatives or organizations which have an approved irrigation system.

NB: The Irrigation System MUST contain the appropriate non-return Valve and Filter.
